



Wawanesa Climate Champions Youth Innovation Grant 2026

OVERVIEW

THE OPPORTUNITY

In alignment with Wawanesa's Youth Stewards Pillar of their [Climate Champions](#) program, Wawanesa, in partnership with Canadian Colleges for a Resilient Recovery (C2R2), are offering funding and support to help accelerate youth-led climate action innovations that have been identified as a gap in the space.

The Youth Innovation Grant will award **five** projects \$30,000 each to initiate or extend a project/innovation that is youth-led and focused on climate adaptation or climate mitigation. The awarded funds must be used within **one year** of being received.

Wawanesa Climate Champions: Youth Innovation Grant is intended to support youth-led climate-related projects in partnership with a C2R2 Partner Institution. It is encouraged that youth participants are engaged in all steps of the project, including the application process. All projects will be made possible with funding from Wawanesa Insurance. While successful projects will be enabled by C2R2 Partner Institutions, youth leaders must be closely included in each project.

There is no limit to the number of applications submitted.

ELIGIBILITY AND PROCESS



- Applicants must be enrolled in a full-time or part-time post-secondary program or have recently graduated (within 2 years) from a post-secondary program at one of the 15 identified [C2R2 Partner Institutions](#).
- Note: Applicants do not need to be enrolled in an environmental/climate related program as all disciplines of study have potential for climate action solutions.
- Participants **must** be considered a youth as defined by the 2026 Wawanesa Climate Champions: Youth Innovation Grants (**18-30 years of age**).
- A designated contact will be assigned with appropriate contact info and process outlined before launch. They will help vet and guide applications.
- Canadian Colleges for a Resilient Recovery is a coalition with representation coast to coast to coast. We encourage youth from all backgrounds, especially those from underrepresented groups, to apply.
- Youth interested in applying must email youthinnovation@resilientcolleges.ca with their name, C2R2 Partner Institution they are enrolled with or have recently graduated from, and what their project would focus on. C2R2 will then connect those who have emailed with a contact at their home institution to discuss the project idea and complete the application form below.
- Applicants must obtain application approval from a designated contact at a C2R2 Partner Institution. The designated contact will help vet and guide applications.

PROJECT REQUIREMENTS

- Projects must focus on climate adaptation
 - or mitigation innovations that will help Canadian communities prepare for and respond to extreme weather and long-term climate impacts, building resilience to floods, wildfires, heat waves, drought, and other climate-related risks. Both mitigation and adaptation projects are welcome, but there will be a greater emphasis on adaptation and extreme weather events.
- Note: Because the challenges communities face across Canada differ, projects can be focused on addressing local Canadian climate challenges and needs.
- **Mitigation definition:** A project that aims to reduce or prevent emissions that are the underlying causes of climate change and therefore extreme weather; i.e. carbon capture and storage, green transport, energy projects.
 -
 - Mitigation can be on an individual level (if it is scalable nationally), a community level, a national level or a sector specific level (e.g., farming).
- **Adaptation definition:** A project that helps community members adjust to or prevent the current and expected extreme weather impacts of climate change. A few examples are listed below as thought starters:



- Innovations in mapping high risk fire/flood areas to help better inform communities of upcoming risks and recommend solutions that will help prevent loss in the future.
 - Innovations in affordable climate resilient housing.
 - Innovations that support farmers' ability to adapt to climate change to help protect the sustainability of our food sources.
- All applicants **must clearly and concisely outline the problem** their climate action project aims to address related to climate change and building climate resilience.
 - All applicants **must briefly outline what is innovative about their project.**
 - The **end impact of the project must benefit a Canadian community or multiple Canadian communities** beyond the walls of a C2R2 college.
 - All applicants must be able to share: **the projected end impact** of the project tied to building climate resilience, **how they will measure outcomes and impact**, and measurable **project outcomes at the end of the one-year** funding period.
 - Projects can vary from seed funding for an innovative idea to become a reality, to scaling the reach or impact of an existing youth-led innovation. Each project must achieve key activities and some outlined milestones, with the project to be fully completed by April 2027. **All applicants must be able to provide a one-year plan outlining how funding will be used to accomplish goals during this timeframe.** If the project will continue beyond this one year, applicants must provide an outline of what this looks like and what phase this one year of funding will support. Projects can be completed in less than one year.
 - All applicants must be able to commit to sharing best practices, insights, and lessons learned from the project process to other youth stewards.
 - To help with impact reporting and storytelling, all applicants must be able to commit to providing ongoing updates throughout the life-course of their funding, providing quotes, photos, videos, and permissions to share information about their project and themselves for use in Wawanesa and C2R2's internal and external communications if selected.

IF AWARDED FUNDING

- You may help drive funded project recognition by working with the C2R2 Partner Institution to draft and publish a media release about the funded project and Wawanesa's support and will be available to local media as requested.
- If possible, you will help increase Wawanesa employee education by providing one employee education session (up to 60 mins.; national; virtual) to share with employees about the work being done, the importance of work related to climate change, and the positive outcomes of this kind of work.
- You will engage Wawanesa employees in the funded projects by building employee volunteer opportunities into project, as available.



- You will ensure all marketing and promotion opportunities are shared with C2R2 and Wawanesa, including the following:
 - Inviting Wawanesa to visit Funded Project site for learning and relationship building.
 - Inviting Wawanesa to capture content for storytelling (personal interviews, photos, video, etc.), where applicable.
 - Inviting Wawanesa to attend Funded Project on-site events and projects, where applicable.
 - Inviting Wawanesa to attend Funded Project meetings/events, where applicable.
 - Provide Wawanesa with speaking opportunity at Funded Project event, where possible.
 - Mentioning the Funded Project and Wawanesa's support at events or in communications, where appropriate.

 - Describe how your project is unique in comparison to other research/projects in the field and how it will fill the gap you have identified.
 - Maximum 150 words.
 18. What is the geographic area that would be impacted through the duration or completion of this project?
 - Identify the region where your project will have immediate and direct impact. A region can be areas with a shared environmental landscape such as the prairies or those bordering the great lakes, a specific city, province or community, students at your institution, etc.
 - Maximum 50 words.
 19. What is the projected end-impact of the project?
 - Describe the immediate and long-term impacts of your project and how it can empower or support the community you are working within.
 - Maximum 150 words.
 20. Can this project's geographic area be expanded to a national level over time? If so, please explain.
 - Think of how your project can be applied on a national scale and what impact it can have across Canada in the long run, beyond the one year.
 - Maximum 150 words.
 21. How will youth be involved in and throughout this project?
 - Eligible projects require youth-led activities. Youth is defined as 18-30 years of age.
 - Maximum 100 words.
 22. Please identify any opportunities within this project that could allow Wawanesa employees or others to engage or volunteer with it.
 - Maximum 100 words.
 23. What will be your measurable project outcomes at the end of one year?
 - Describe **all** expected project outcomes at the end of one year. If you expect you will require less than one year, please describe.
 - Youth will be required to report on outcomes during the final report.
 - Please list your measurable outcomes in number format with a short description of each outcome (i.e., 1-xxx, 2-xxx, etc.).
 - When responding to this question, consider the SMART—Specific, Measurable, Attainable, Realistic, Timely—principles of goal setting.

- Please provide a detailed budget that outlines how the awarded funds will be used to accelerate your project throughout the proposed timeline
 - Budget template provided in application form.
 - Ensure the budget provided includes all expected costs to be incurred throughout the funding duration of the project.
 - Please ensure any salary listed does not exceed more than 75% of the budget total.
 - Budget development must be completed in close partnership with the C2R2 Partner Institution. Funds will be distributed to the C2R2 Partner Institution to enable the Youth Innovation Grants. Funds will not be provided directly to an individual youth participant.

RUBRIC

The evaluation committee holds the right to decide on which projects will receive the final funding, however, the rubric below will be used to aid application assessments. All climate solutions will be evaluated equally. In the event of closely ranked applications, preference will be given to projects demonstrating innovative approaches to **climate adaptation**
